# 2010 MARTY GLENN SENIOR TOURNAMENT RULES

1. This is a singles tournament only.
2. You can enter a maximum of two times, but can only cash once in your age division.
3. Bowlers must be 55 years or older, on or before March 1, 2010, and must be a member of USBC and Champaign Area USBC for the 2009-10 season.
4. Bowlers should use highest 2008-2009 book average. If no 2008-09 average, bowler is to use his/her highest league average as of March 1, 2010 based on at least 12 games. If a bowler does not have a qualifying average, tournament management will assign an average based on USBC Rule 319b with women being assigned a minimum average of 140 and men a minimum average of 160.
5. Handicap will be 100% of difference between bowler's average and 230.
6. Failure to use correct average shall disqualify score if submitted average is lower than correct average, resulting in more handicap. USBC rule 319a Parts 1, 3, 4 and 5 will apply to all entrants. USBC Rules 319c, 319d and 319e will not apply for this tournament
7. Trophies and cash prizes will be awarded to first place winners in the following divisions for men and women classes individually: 55-59, 60-64, 65-69,70-74,75-79 and 80 plus. In case of a tie for first place, co-champions will be declared, dual trophies awarded and prize money split *evenly*. *In case of a tie* for any other positions, positions will be combined and money evenly divided. Prizes will be paid in a one in five ratio for each division.
8. Entry fee is \$25.00: \$15.00 bowling and expense fee and \$10.00 prize money.
